Discretionary Funding Guidelines

- Two types of discretionary funding: Expense and Capital
- Any non-profit or public school qualifies to receive funding
 - *All NYC charter schools that operate in a private space* are considered non-profits in the application process and will apply for discretionary capital funds through CAPGRANTS
 - If your school is co-located you will apply for discretionary capital funds by making a request from your Councilmember office
- Awarded on an annual (fiscal) basis to entities that service and meet the needs of the public. Expense funding must be spent within the Fiscal Year it was designated.
- Charter schools must deliver and use the services for which they are receiving funding

Discretionary Funding Amounts

- Council Members are allotted ~\$685,000–760,000 for district related expense projects
 - Council Speaker receives a higher amount, *Speaker's Initiative*
 - Districts with populations with high poverty rates receive additional funding which is referred to as the Anti-poverty fund
- The Council receives ~\$5M for capital projects
 - Generally, \$2–3M are granted to schools (technology and building upgrades)
- Borough Presidents receive ~\$25–30M for capital projects (*amount varies depending upon budget*)
 - \$2–3M granted to schools (technology and building upgrades)



Discretionary Expense Funding

Expense Funding

- Expense Funding is an appropriated sum of money in the City's expense budget allocated to eligible not-for-profit organizations to provide programs, services and/or make small equipment purchases.
- Distributed by City Councilmembers from NYC's expense budget
- Applicants must include organization's qualifications and a description of the proposed project
 - Demonstrate ability to service community at large
- Schools (and subcontractors) must disclose any potential conflicts of interest
- Different Types of Expense funding eligible for Charter Schools:
 - Youth Programs
 - Local Initiatives
 - Member Designated Initiatives (Cultural After-School Adventures (CASA) & Digital Inclusion & Literacy Initiative)

Expense Funding: Youth Programs

- Allocated to provide services *outside of school hours* for youth or community development:
 - After-school programming
 - Arts programming
 - Summer programming
- Funding average: \$5,000 – \$10,000
- **Example:**
 - Amber Charter School received \$5,000 To support Amber Charter School's debate team in Council District 10. (FY25)
 - Imagine Me Leadership Charter School received \$10,000 to be used to support the establishment and operation of a Library Media Center for students and community members. (FY25)

Expense Funding: Local Initiatives

- Funding is allocated to provide resources and services to meet local community needs
- Charters can apply for funding individually or in conjunction with a co-located school or Community Based Organization (CBO)
- Funding average: \$5,000 - \$10,000
- **Example:**
 - Imagine Me Leadership Charter School received \$18,750 Funds will support the costs associated with providing the additional enrichment programming, including facility rental fees and transportation expenses for the school's diverse afterschool programming. (FY25)
 - Peninsula Preparatory Academy Charter received \$10,000 to support the virtual after-school intervention programs that support educational enrichment. (FY25)

Expense Funding: Member Designated Initiatives (MDI's)

- Initiatives with a specific purpose and guidelines that are equally split and designated by each Council Member.
- Charters can apply for funding individually or in conjunction with a co-located school or Community Based Organization (CBO)
- Different Types of Member Designated Initiatives eligible for Charters:
 - Cultural After-School Adventure (CASA) which engages cultural programs and institutions to provide arts enrichment to students through after-school programs.
 - Digital Inclusion and Literacy Initiative which supports programing in each of the 51 Council Districts that provide computer-based training and learning, technical skill development, improve internet access, and offer free public streaming services.
- Funding average: \$10,000 - \$20,000
- **Example:**
 - Hebrew Language Academy Charter School received \$20,000 via the Digital Inclusion and Literacy Initiative which provides computer-based training and learning, technical skill development, improve internet access, and offer free public streaming services. (FY25)
 - The Children's Museum of the Arts received \$20,000 to provide arts enrichment to students through after-school programs at the Renaissance Charter School. (FY25)

Expense Funding

- Co-located schools
 - District school – take lead on application
- Charters treated as non-profits in application, prequalification, clearance and contracting process.

Discretionary Capital Funding

Capital Funding

- Distributed by Councilmembers and Borough Presidents
 - Schools generally receive bulk of capital projects
 - Councilmembers can opt to use Participatory Budgeting to allocate this funding (*Idea submission closes on November 22, 2024*)
- The deadline to apply for funding through your local Borough President is in late February.
- Eligible projects must be proposed for a defined City purpose
- If you own your building, you're eligible for real property and moveable property funds
 - If you do not own your building, and rent from a private entity, you are ONLY eligible for moveable property funds
- Types of projects eligible:
 - Real Property
 - Playground renovations
 - Building upgrades (*Auditorium upgrade, bathroom renovation, etc*)
 - Moveable Property (Co-located schools apply through your local councilmember. Schools operating in private space will apply for this funding through CapGrants)
 - Mobile science labs
 - Laptop cart, technology

Capital Funding

- Sometimes referenced to as *Reso A* funding
 - Reso A: school-specific capital improvement(s) or enhancement(s)
- Non co-located schools applying for Capital funding must have received expense funding from FY23-25.
- Construction projects on privately owned buildings are considered reimbursement funding; schools will need to show other source(s) of funding for the project.
- Councilmembers and Borough Presidents can both supplement funding for one project.

Capital Funding

Budget Timeline (as listed by SCA)

- **January - March** - Elected officials contact schools to identify potential projects
- **May - June** - City budget negotiations and adoption of the City's budget which includes new school projects
- **July 1st** - Start of the new Fiscal Year
- **Summer** - Schools notified of awards from Elected Officials
- **July - September** - Review and creation of newly funded school projects by SCA
- **September - February** - SCA receives final budget authorization from the Office of Management and Budget
- **October - March** - SCA begins project scope and design process and schools are contacted by their project team. Notices for Technology projects are published in the Principals' Weekly.

Capital Projects: Moveable Property

- Moveable property: equipment or furniture that is *not* (or minimally) attached to real property, or vehicles
 - Note: Furniture will only be provided if it applies to a renovation project. (ex: Cafeteria renovation will include qualified furniture)
- Minimum council contribution for moveable property: \$50,000
- *All* charter schools are encouraged to apply for mobile science labs.
- **Example:** Integration Charter School received \$60,000 for a camera system (FY24)

Capital Projects: Real Property

- Real property: construction, reconstruction/renovations, land/buildings, fixtures
- Proposed property must be used and owned by the applicant school
- Funding minimum contribution: \$500,000
- **Note**: The project must be used for a City purpose for its entire useful life.
- **Example**:
 - Summit Academy and P.S. 676 received \$650,000 to upgrade a decades-old audio-communications system in the AV room (FY22)
 - Success Academy Charter School received \$527,000 for playground construction (FY18)

FY 2026 Timeline

- Schools operating in a private space will submit applications online
 - Dates will be published early January 2025 on [CapGrants](#)
 - Non co-located schools that would like to apply for funding through both City Council and Borough President- would need to meet the earlier deadline
- Capital Funding – City Council
 - Application opening January 2025* and closes in March 2025*
- Capital Funding – Borough Presidents
 - Application opening January 2025* and closes in late February 2025
- **Note:** You can supplement your application for funding to the Borough President's Office with an application to your local Councilmember.

- FY26 Expense Application Release Date: Friday, January 3rd, 2025*
- FY26 Expense Application Submission Deadline: Monday, February 24th, 2025*
- Designation Review Process: April 2025–June 2025
- Fiscal Year 2026 Begins: July 1st, 2025
- Fiscal Year 2026 Ends: June 30th, 2026

7. Staffing information regarding programs/services
8. Certificate of Incorporation (for those incorporated on or after July 1, 2022)

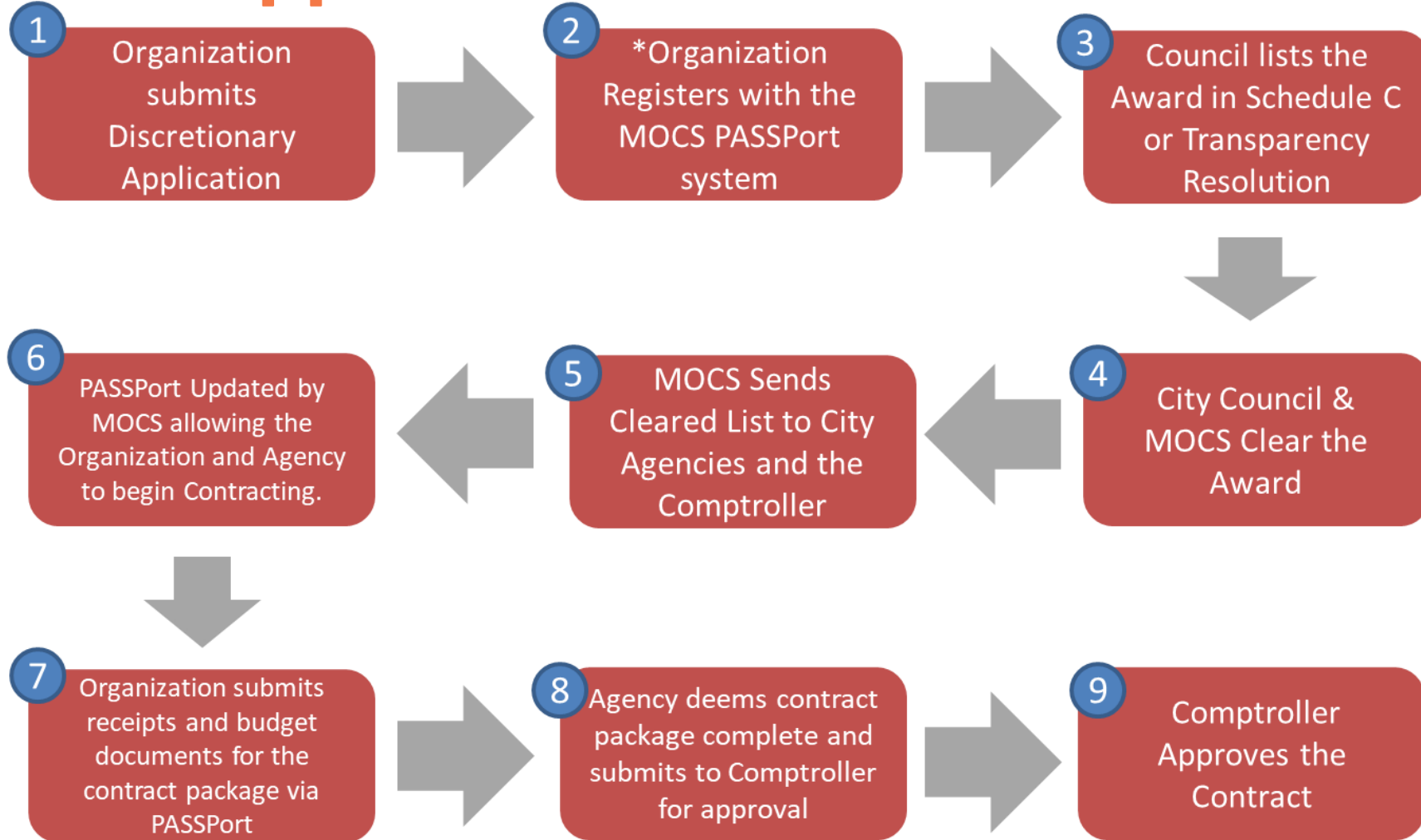

- Schedule meetings during the project review period (January – April)
- Write your Council Member a one-page letter describing the project in detail and include proof of your non-profit status. After funds are issued, the City publishes a complete list, which includes:
 - Recipient Name
 - Award Amount
 - Sponsoring Member(s)
 - Brief Description of How Funds Will Be Used

Charters Applying for Capital: Private Space

- Create an account on the [NYC CapGrants portal](#)
- Application process: 4-5 hours
 - Capital funding application process is bulkier and requires more documentation
- Upload required documents and apply
 - Organization form
 - All relevant and required attachments (e.g. audited financials)

Sample Funds Request Letter

Dear Councilmember,

As a public charter school, HPCHS does not have access to the categorical grant funding that traditional public schools receive. As such, we are at a significant disadvantage in funding a variety of school needs, including after-school programs.

Our students would benefit greatly from learning chess, as it would help develop critical and strategic thinking skills. In that sense, we would like to start an after-school chess class twice a week, which will be made accessible to the outside community.

To address this need, HPCHS requests a grant to support the operations of the program for the duration of the upcoming school year.

Funds Requested:

Instructors and fees: 50 sessions @ \$150/session (to cover two instructors) = \$7,500

Materials & misc. expenses: \$2,500
